hereby agree and acknowledge that:

3. I hereby confirm that I comply with all the aspects of Part 91 of the South African Civil Aviation Regulations 2011 that are relevant to the mission as described in the Bateleurs document for which I have volunteered to undertake. Attention is drawn especially to recency and qualifications;
4. I have agreed to fly, on behalf of The Bateleurs – Flying for the Environment in Africa, a Non Profit Company with registration no. 1998/017783/08 (“the NPC”), in a _____ (“the aircraft”), in and around any applicable locale on an ongoing basis.
5. neither the NPC, nor the directors, shareholders or members thereof, (hereinafter collectively referred to as “the specified parties”) shall in any way whatsoever be liable to me for any loss, liability, damage or expense (including without limiting the generality of the foregoing), any damage caused at any time to me or to my property (including, without limitation, the aircraft) or for any injury or loss of life sustained by me (including special damages), and damages of a consequential nature, or for any loss suffered by me arising from the death of a passenger, of any nature whatsoever which I may suffer as a result of or which may be attributable to any act or omission (whether intentional, negligent, grossly negligent or otherwise) of any of the specified parties, and I release each of the specified parties against all such loss, liability, damage or expense;

10. the validity, interpretation and construction of this indemnity or any matter arising out of the conclusion or termination hereof shall be governed by South African law and I consent and submit to the non-exclusive jurisdiction of the South Gauteng High Court for all purposes in connection herewith.
